Eye Contact:

In case of eye contact, hold eyelids open and rinse with water for at least 15 minutes. Seek medical attention if symptoms occur.

5 Fire Fighting Measures

6 Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved dust/particulate filter respirator and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe dust. Ensure adequate ventilation. Avoid generating dust.

Liquid spills may be very slippery.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and sweep granules into a pile and shovel into drums for subsequent disposal. Avoid generating dust. Provide adequate ventilation. Wash spill area with water.

If product is spilt in liquid form absorb with sand, earth, vermiculite or some other absorbent material.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust.

Special care must be taken if large quantities of powder are decanted without local ventilation. Avoid generating dust.

Food, beverages and tobacco products should not be stored or consumed where this material is in use.

Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:
